Assist families becoming financially debt-free and spread the gospel of our Lord Jesus Christ.

4a (Code:) (Expenses \$ 718,645 including grants of \$ 0) (Revenue \$ 930,570) In 2010, 306 new clients chose to utilize our Debt Management Program to achieve their goal of living a debt-free lifestyle. 1,543 clients completed the program successfully in 2010. At the end of 2010, we had 2,010 active Debt Management Program participants. The Debt Management Program provides clients with an opportunity to consolidate their monthly unsecured debt payments and to receive interest rate and/or fee concessions from their creditors.

4b (Code:) (Expenses \$ 218,425 including grants of \$ 0) (Revenue \$ 0) In 2010, we provided Credit and Budget Counseling services to 698 new clients in 31 states at no charge to the client. Our counseling services assist individuals and families in developing an accurate budget, empowering them to manage their own personal finances, educating them on the options available to them to achieve a debt-free lifestyle, and laying out a personal action plan to achieve that goal. We maintained credit counseling licenses and/or registrations as required in 12 states, and we are authorized to do business in a total of 31 states. In 2010, 306 of the clients that were counseled chose to utilize our Debt Management Program, and 392 clients chose to use the tools and information they received in their counseling session to move forward on their own.

4c (Code:) (Expenses \$ 251,550 including grants of \$ 0) (Revenue \$ 109,714) In 2010, we opened the Family Life Thrift Store in Fargo, ND. The mission of the Family Life Thrift Store is "to provide quality merchandise at affordable prices in support of local Christian ministries and educational opportunities." The Thrift Store furthers our overall mission "to assist families in becoming financially debt-free and to spread the Gospel of our Lord Jesus Christ" by providing area families and individuals with an opportunity to meet their basic needs at affordable prices and creating opportunities for them to receive free Bibles, submit prayer requests, and learn more about Jesus Christ. In 2010, we were able to give away 88 Bibles and received donations of merchandise from over 500 people.

The value of the deferred compensation liability is being accrued over the expected remaining term of employment with a total estimated liability based on the average life expectancy of the key employees. The Organization's deferred compensation expense totaled \$64,817 for the year 2010. The plans are not currently funded. In 2010, the total payments made under the plan were \$44,996. In 2009, the total payments made under the plan were \$51,483. No amounts were paid in year 2008 and 2007.
